# NOTICE OF RACE

## The Organising Authority is the Belmont 16ft Sailing Club

- Rules:** The regatta will be governed by *The Racing Rules of Sailing* (RRS), the special regulations of Yachting Australia, the rules of the 16ft Skiff class, the Notice of Race (except as any of these are altered by the Sailing Instructions) and by the Sailing Instructions.
- Rule Changes:** Rule 60.1(a) & (b) are deleted. Rule 44.1 is changed so that the Two-Turn Penalty is replaced by the One-Turn Penalty.
- Eligibility & Entry:** The regatta is open to all Association registered 16ft Skiffs. Eligible boats may enter by completing the attached form and e-mailing it to the Belmont 16ft Sailing Club by **Monday 29 January 2024**. All skippers are reminded they must comply with RRS 40 & 46 and the YA Prescription thereto. All boats shall complete Registration at Race HQ by 10:30am on Saturday 3rd February 2024. Sailors who have not yet attained their 18<sup>th</sup> birthday shall submit a signed Parental Consent form attached at Registration.
- Series:** The regatta will consist of a qualification series (4 groups), semi-finals (2 groups) and finals series (1 group). The number of boats in each group will be determined by overall entry numbers.
- Schedule:** Saturday 3rd February 2024    not before 1100hrs                      First Warning Signal
- Sailing Instructions:** The sailing instructions will be available on Saturday 3rd February 2024 at the B16ftSC.
- Venue:** The regatta site will be the Belmont 16ft Sailing Club. The racing area will be on the waters of Belmont Bay, Lake Macquarie, NSW.
- Courses:** The courses to be sailed will be of windward-leeward configuration as described in the sailing instructions.
- Scoring:** A Low Point Score system will be used.
- Prizes:** Prizes will be presented on Saturday 3rd February 2024 as soon as practicable after the conclusion of racing. A crew member from each boat **must be present at the presentation in order to claim money**.
- Liability:** Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The Organising Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta. - Insurance:** Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$10 million per incident or the equivalent.
